As per State Govt. norms/guidelines and Rehabilitation Council of India (RCI) approved qualification at secondary and senior secondary stage, the minimum qualification for the appointment of Special Educator is as under:-

(1) Graduation with at least 50% marks and B.Ed. (Special Education) or B.Ed (General) with diploma in Special Education or equivalent from a recognized University/Institution.

OR

(2) Post Graduate in relevant subject with at least 50% marks and B.Ed (Special Education) or B.Ed (General) with diploma in Special Education or equivalent from a recognized University/Institution.

OR

- (3) Post Graduation in relevant subject with at least 50% marks and diploma in Special Education or equivalent from a recognized University/Institution.
- (4) Hindi/ Sanskrit upto Matric standard as one of the subject.

Note: All qualifications in Special Education should be recognized from Rehabilitation Council of India (RCI), Institutions.

Desirable Qualifications:

- Teacher with qualifications in single disability area will be encouraged to specialize in other disability areas to take care of wide range of diversities in a general school.
- Knowledge of computers.

Age Limit: 18-42 years as on the date of advertisement. Relaxation in the case of SC/BC candidate will be applicable as per the norms of Haryana Govt. only
